Additionally, students must **earn a minimum grade of “C” in ALL courses** required in the curriculum to earn the Associate of Applied Science in Criminal Justice.

All BPCC students are expected to be familiar with College policies, requirements, procedures and regulations. Students must assume final responsibility for being acquainted with College policies. In no case will a regulation be waived or an exception be granted because a student pleads ignorance of the regulation.

Students pursuing associate degrees, academic certificates, or technical competency areas at BPCC must declare their intent to do so. Curricular requirements become effective at the date of the declaration of the academic major and do not date from the point of original enrollment in the College. If the student resigns or does not enroll for one semester, the student would have to meet the requirements of a new curriculum.

The student is responsible with all the requirements of the degree program and should consult with his/her academic advisor regularly. Each student assumes the responsibility for scheduling courses which are applicable to degrees and for taking courses in proper sequence to ensure the orderly progression of work.

This certificate is a “stackable” certificate, allowing the student to continue studies to complete the Associate of Applied Science in Criminal Justice Degree.

POST Certification credits Applied to Criminal Justice Degree

Bossier Parish Community College is providing expanded educational opportunities for peace officers completing POST Certification. Fifteen (15) hours of credit will be given in criminal justice courses at BPCC.
